On 07-07-12 at 0434, R/O Niebuhr responded with P/O Ruha to the report of a fight in front of 2227 54St. Upon arrival, the R/O observed two m/b suspects walking out of the road way and on to the sidewalk. When they reached the sidewalk, they both squared up with each other and appeared as though they were going to continue to fight. The suspect with no shirt and white shorts, later identified as Tamirius Gaston, appeared to be backing away from the second suspect, (no shirt, white pants, no shoes), later identified as Keenan Smith. Keenan continued to approach Tamirius with his arms up looking ready to fist fight with him. The R/O then observed P/O Ruha approaching both suspects with his electronic control device (Taser) out. The R/O heard P/O Ruha commanding both suspects to get down on the ground. Tamirius listened to P/O Ruha's command and got down on the ground. The R/O observed Keenan turn and square up to P/O Ruha and it appeared that Keenan may try and fight with Ruha. The R/O heard P/O Ruha continue to give loud and clear commands for Keenan to get down on the ground and warning him that he will be "Tased" if he did not comply. Keenan continued to refuse to comply with Ruha's commands and P/O Ruha used the electronic control device on him.

The R/O moved in and took both suspects into custody. The R/O placed Tamirius in the back of his squad. Keenan continued to be combative with officers on scene while they attempted to search him before securing him in a squad. He was pushing and pulling away from the officers as they detained him against the back of the squad. He was eventually placed in the back of P/O Ruha's squad and transported to KSD jail.


The R/O transported Tamirius to the KSD jail. While enroute, Tamirius stated without being questioned that Keenan is the brother of his girlfriend. He was extremely intoxicated and was claiming to be "tougher" than Tamirius. He continued to bother Tamirius calling him names and pushing him to provoke him to fight. Eventually Tamirius could not take anymore and they got into a fist fight in the middle of 54St. Tamirius did not wish to pursue charges against


